PLAN IN ACTION

One of Scott's most notable cases involved Tulsa Police Officer Betty Shelby, who was charged with first-degree manslaughter in 2016 following an officer-involved shooting. With support from the FOP Legal Defense Plan, Scott and co-counsel Shannon McMurray were able to build a robust legal defense that included four expert witnesses. The Plan covered more than \$420,000 in legal expenses. Officer Shelby was acquitted in May 2017.

"No other plan out there will go the distance like the FOP Legal Defense Plan," Scott said.

In another case, Scott helped a newer officer who was wrongfully terminated after mishandling abandoned ammunition based on poor direction from an employer. After ten months, the officer was reinstated with back pay.

"Getting an officer's job back after an unfair termination is one of the most satisfying things a lawyer can experience," Scott said.
